THE u3a IN KENNET (WILTSHIRE) ANNUAL GENERAL MEETING

Minutes of the 32nd Annual General Meeting 30th October 2024 at 2.15pm

In the Town Hall, Marlborough

1. Chairman's welcome & apologies for absence

The Chair welcomed everyone present and declared the meeting quorate with 140 members present. Voting would be by a show of hands, and by proxy for those unable to be present. Apologies and proxy votes had been received from 99 u3a in Kennet members.

2. Minutes of the AGM held on 25th October 2023

Acceptance of the Minutes of the 2023 AGM was proposed by Jeff Hide and seconded by Annette Weaver. The membership gave their approval by a show of hands and there were no matters arising.

3. 3. Chair's Introduction and Trustees' Report (attached)

Jill Turner presented an outline of the year's developments:

- the total membership had grown from 672 to 708
- u3a in Kennet had 64 Groups including new groups for Global History, Science discussion and a second Poetry Appreciation Group.
- o the Coffee Exchange meetings in Marlborough Town Hall were very well-attended
- the Kennet u3a Talks in Kennet Valley Hall continued to be successful
- other events included a New Members' Lunch and the u3a in Kennet Open Day on 13th September 2023

Acceptance of the Trustees' report was proposed by David Hammond and seconded by Jacqui Hide.

4. Treasurer's Report and Accounts (attached)

Alastair Sheen presented his Treasurer's Report and the Accounts, which were looking very healthy. Acceptance of the Accounts was proposed by Alison Dewar and seconded by Cate Mitchell, and approved by a show of hands.

5. Appointment of Examiner of Accounts for 2023/4

Kiaran Roughan had offered to take over as Examiner of Accounts for 2024/5. Acceptance was proposed by Alastair Sheen, seconded by David Hammond and approved by a show of hands.

5. Election of Officers and Committee Members

The Chair explained that the u3a Executive Committee comprised four officer posts (Chair, Vice Chair, Treasurer and Secretary) and up to eight other Committee members. Three additional co options could be made in one year. Two co-options: David Moakes and John Slaughter, had been made during the year.

John Slaughter had been proposed for election by John Youngman and seconded by Gary Partridge, and was duly elected to the Committee.

The meeting ended at 2.40pm and was followed by a very interesting talk by Bob Holman on 'Marlborough Underground'.

1. Chair's introduction

I am pleased to present the following report on my second year in post as the Chair of u3a in Kennet.

This has been a year in which the very encouraging growth in our membership numbers has continued to exceed 700 by the year end. Several new Groups were established too thereby widening the range of interests and activities that are available to local people. Our regular monthly meetings have become increasingly well attended and supported by our hard working team of 'Really Useful Group' volunteers and a variety of interesting speakers.

My thanks are due to all members of the Executive Committee and to our Group Leaders whose individual and collective efforts have contributed to the growth and continued development of u3a in Kennet during the year.

2. u3a in Kennet - aims

The u3a movement aims to provide 'public benefit' and the charitable purpose of u3a in Kennet is:

'The advancement of education and, in particular the education of older people and those who are retired from full time work by all means, including associated activities conducive to learning and personal development, in Marlborough and its surrounding locality'

thereby reflecting the Third Age Principles of membership, self-help learning and mutual aid.

3. u3a in Kennet

3a) Membership

The membership of the u3a in Kennet grew during the year and by 31st July 2024 comprised:

- Ordinary 693 (661 in July 2023)
- Retired 1 (1 in July 2023)
- Associate –14 (10 in July 2023)
- Totals 708 (672 in July 2023)

3b) Groups – numbers / progress

Groups have again flourished this year thanks in particular to the hard work, commitment and dedication of our Group Leaders and to the support and enthusiastic participation of the group members.

There are currently 64 groups available to members, most of which now meet face to face. During the year several new groups have started up successfully. These include: Global History, Science Discussion, a second Poetry Appreciation Group and a Walking Tennis group was initiated and is now

in place. Further discussion is ongoing about some other proposed new groups.

We have also welcomed a number of new Group Leaders this year and have given our thanks to some Group Leaders who stepped down after several years successfully leading their groups.

Particular thanks are due to the members of the 'Really Useful Group' (RUG) who support the catering and other arrangements at our meetings and events.

3c) Programme of events

The well attended quarterly 'Kennet u3a Talks' continued during the year and we welcomed a range of interesting speakers who addressed the following topics:

The monthly 'Coffee Exchange' sessions continued during the year at the Town Hall with a slight change of format to allow more time for members to meet and chat with friends prior to the monthly speaker slot and sharing of news about future events. These sessions became increasingly popular with current and potential members such that growing attendance figures necessitated a move from the Court Room to the larger Assembly Room.

A lunch was held during the year providing a welcome for new members enabling them to meet with Group Leaders and Executive Committee members and helping them to choose groups to join.

3d) Governance: Trustees / Executive Committee membership / meetings

u3a in Kennet is led by an Executive Committee and governed by its Constitution which is based on the national model constitution and was adopted on 24th October 2018 and amended on 25th March 2021.

The Annual General Meeting was held on 25th October 2023 resulting in the re-election of Annette Weaver as Honorary Secretary. Alastair Sheen was elected as Honorary Treasurer and Hamzah was elected as Committee Member with responsibility for technical support.

David Moakes was co-opted during the year (January 2024) and focussed on supporting the publicity arrangements.

In addition to the Committee members listed above the Committee acknowledges the support provided by members David Hammond (former Chairman) and Pat Harper in the production of publicity materials and maintenance of our website respectively.

The Executive Committee met on five occasions at two monthly intervals during 2023-24.

The Chair joined the regular meetings of the national u3a Chairs and the Chair and several Committee members attended meetings of the Bath and Wiltshire u3a Network during the year with a specific focus on aspects such as overall governance, finance, groups, publicity and sourcing speakers.

3e) u3a in Kennet – local publicity and profile,

Our growing membership indicates that u3a in Kennet is becoming increasingly well known in the local area. We believe this is a consequence of our positive publicity initiatives including our flyers and website, regular meetings and events, local media notably 'Marlborough News' and significantly through members sharing information with friends and relations. 'Word of mouth' is an important means of communication about the benefits of u3a membership.

During the year u3a in Kennet was invited to attend a meeting of the local branch of 'Business Network International' to share information about membership with local people who may be looking ahead to retirement. In addition we attended the Marlborough Health and Wellbeing Day in July as an exhibitor which focussed on the varied health benefits of membership.

Local organisations have sought to make connections with us including 'Marlborough Tennis' which offered taster sessions for walking tennis, the Marlborough Lit Fest and the Marlborough Festival organisers who offered discounted tickets for our members at the event.

3f) Open Day - 13th September 2023

Following an introduction by the Town Crier the Mayor opened the annual event which aimed to increase the u3a profile in Marlborough and the surrounding area. u3a in Kennet was showcased with a poster exhibition in the Town Hall along with art work, photographs, music from the Recorder Group and a live demonstration of table tennis. Committee members and Group Leaders welcomed around 200 visitors to the exhibition and recruited 24 new members on the day.

4. Communications: Newsletters, website and social media

Regular and effective communication with members was maintained with the monthly newsletters and the annual yearbook. The website was updated regularly with new events and information about group activities.

A new 'Welcome leaflet' was produced identifying the meeting arrangements for all of the groups on a one page document along with a new publicity flyer local leaflet for wider publicity.

In addition u3a in Kennet has two Facebook pages: one for members and a public facing version.

Further helpful local publicity was secured with a link to u3a news in 'Marlborough News'.

5. Financial matters

5a) Treasurer's Report and Accounts for the financial Year 1st August 2023 - 31st July 2024

u3a in Kennet is a voluntary self-help organisation that seeks to advance the education and social interaction of older people and those who are retired from full time work in Marlborough and its surrounding locality.

The u3a operates through a Committee of trustees elected at its Annual General Meeting. It mainly carries out its activities through groups led by Group Leaders.

The main source of income is member subscriptions. The accompanying accounts show that subscription income increased by 4.25% to £8,671 compared to 2022-23 (£8,318).

The total general income for the year was £10,421 (£10,548 in 2022-23).

Total general expenditure for the year was £10,285 (£11,906 in 2022-23). This resulted in a modest surplus of income over expenditure for the year of £136 (£1,359 shortfall 2022-23).

The main areas of expenditure were:

The National Capitation, Beacon management fees and the Third Age Matters Magazine postage were 12% higher this year because of the increase in the number of members.

Venue hire for u3a wide events was a little higher than in 2022-23, There were no expenses incurred attending any national or regional u3a meetings.

Our monthly Coffee Exchanges and quarterly Kennet Talks regularly attract 80-100 members and continue to be very popular. A New Members' Lunch was held in Kennet Valley Hall in November 2023.

Reserves of £16,420 (£16,472 2022-23) were held at the end of the year.

Groups income totalled £15,363 (£12,321). Groups expenditure totalled £13,998 (£13,176). This resulted in a surplus of £1,365, which includes advance payments for trips taking place in September & October.

Group funds carried over in the bank totalled £4,836 (£3,533.86) at the year end. A total of £252 was also carried over as cash.

Total funds held at the year-end (including Groups cash) were £25,078 (£25,023)

The Accounts for 2023-2024 have been examined and agreed by *Mr David Hargrave, an independent accountant who is not a u3a member.*

5b) Asset register

The u3a in Kennet asset register was checked and updated during the year. The total value of the assets remains within the limits of the standard u3a Trust insurance policy.

6. Summary

Following the challenges imposed by the Covid-19 pandemic, u3a in Kennet continued to grow and developed its range of support for members during the year from August 2023–July 2024.

The Executive Committee thanks all Group Leaders for their active and committed support for u3a in Kennet and all members for their interest and involvement.
