

COFFEE EXCHANGE NOVEMBER 2025

'THE LIVERY COMPANIES OF LONDON EXPLAINED' by ALAN HAWKINS

Our November Coffee Exchange was another well attended session and members were interested to learn about the history of the Livery Companies.

Alan had been the Chief Executive of the British Retailers Association and subsequently became Master of the Worshipful Company of Builders Merchants in 2023-24. He retains an active interest in several boards, trusts and pension schemes.

He began by tracing the very early history of the Companies dating from 1155 and then through the subsequent Tudor period with the early guilds and the designation of 'Freemen' who were eligible to work in the City of London. In turn 'Freemen' could become 'Liverymen' after training.

Some of the earliest trades to be established were the weavers in 1125 followed by bakers (the origin of the 'baker's dozen'), grocers, mercers and drapers. The rivalry between the latter two resulted in the saying of being at '6s and 7s) with agreement to alternate their position on an annual basis.

No new Livery companies were formed between 1708 until 1928 and the creation of the Master Mariners' company in recognition of their contribution to the 1st World War. The most recent companies include Nurses, Entrepreneurs and Communicators.

All Liverymen attend Livery Hall ceremonies including the silent robing events.

We learnt about the current work of the Companies spanning from support for charities including those working in the fields of mental health and rehabilitation of ex-prisoners and 250 London cabbies taking a group of disadvantaged children to Disney World in Paris.

The coat of arms of the Builders Merchants' Company features an owl (wisdom) and a pelican (representing homes) holding images of building materials: a brick and a log. The company has

links with each of the three armed forces including the Princess of Wales' Royal Regiment. The Company funded the anointing screen for the coronation of King Charles 111.

The Livery Companies and the London City Corporation embraces its rich history with pride and visible displays of status including the splendid robes as well as the beautiful and historic Halls such as the Drapers' Hall which can seat 200 for dinner and the Mansion House with their richly decorated rooms and ceilings, silverware and splendid events. The latter being of particular note such that Alan's final slide drew our morning to a close with a picture of him struggling to fasten his jacket buttons after his year in office and many lavish dinners.
